

NOTICE OF MEETING

FORT BEND COUNTY MUNICIPAL UTILITY DISTRICT NO. 149

The Board of Directors of Fort Bend County Municipal Utility District No. 149 (“District”) will hold a regular meeting on **Monday, June 23, 2025, at 1:30 p.m.** at the offices of The Muller Law Group, PLLC, 202 Century Square Boulevard, Sugar Land, Texas 77478, to discuss and, if appropriate, act upon the following items:

1. Public comments.
2. Minutes.
3. Law enforcement matters, including:
 - a. monthly law enforcement report; and
 - b. security services contract
4. Tax assessment and collection matters, including delinquent tax collections, installment agreements, and payment of tax bills.
5. Operation of District facilities, including:
 - a. billing, repairs, and maintenance;
 - b. regional water supply system matters; and
 - c. hearing on termination of water and sewer service to delinquent customers and authorize termination of service.
6. Engineering matters related to projects, improvements, or services for the District, including:
 - a. authorization to design construction projects and approval of contracts for design of construction projects;
 - b. approval of plans and specifications and authorization to advertise for bids or proposals for construction projects;
 - c. review of bids, award of contracts and authorization to execute letter financing agreement for construction of projects in the service area;
 - d. approval of pay estimates, change orders, and final acceptance of projects, including:
 - i. rehabilitation of drainage facilities for Millwood at Riverstone – Sections 2 and 3; and
 - ii. natural gas generator backup for District lift stations; and
 - e. deeds, easements, utility conveyances, and consents to encroachment.
7. Reimbursement of eligible expenses from Association of Water Board Directors summer conference, and authorize attendance at winter conference.
8. Financial and bookkeeping matters, including:
 - a. payment of the bills and review of investments;
 - b. budget for fiscal year end July 31, 2026; and
 - c. budget for regional water supply facilities for fiscal year end July 31, 2026.
9. City of Missouri City Matters, including:
 - a. Master Drainage Plan update;
 - b. regional wastewater treatment plant matters;
 - c. surface water distribution; and
 - d. fire protection services and fees.
10. Stormwater Management Program, including public comments and training.

11. Riverstone Homeowners Association Matters.
12. Website, social media, and communications matters.
13. Mosquito Spraying.
14. Report on proposed District projects, action items, and resident inquiries.
